# INCLUDING ALL NONINSURANCE CHARGES AND CONTRACT FEES

The performance results shown below reflect deductions for management fees and other expenses of the portfolios/funds (including Rule 12b-1 distribution fees where applicable), the Platinum Investor VIP variable universal life mortality and expense risk charge of 0.70 percent annually (0.35 percent after 10 years and 0.15 percent after 20 years) and all other noninsurance charges and contract fees. Insurance-related charges, including surrender charges, cost of insurance and the monthly expense charge, are not deducted in this example. Results would be significantly lower if these expenses were included. These results do not reflect election of available optional features or riders, including the Guaranteed Minimum Withdrawal Benefit Rider ("GMWB Rider"). If the GMWB Rider has been selected, an additional charge of 0.75 percent annually is deducted from your accumulation value invested in the variable investment options.
